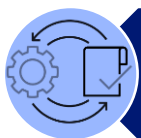

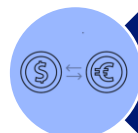

Case Study

Maribyrnong City Council – Cybersecurity Governance Healthcheck

Maribyrnong City Council (MCC) has invested significant resources in enhancing the approach to cybersecurity risk management. MCC has a small, but dedicated IT Management function.



The MCC Audit & Risk Committee (ARC) requested a cybersecurity governance healthcheck to assess cyber threat mitigation strategies and cyber resilience.

A healthcheck style approach featuring a light touch desktop review of key strategies, programs, policies and procedures and discussion with key managers was prepared. This was proposed to ensure an efficient utilisation of available audit resources and to minimise impact on MCC staff and business.

The approach included a gap analysis against the best practice requirements of the Australian Cyber Security Centre (www.cyber.gov.au) and relevant standards including VPDSS.

The Healthcheck Report was well received by the MCC ARC and Management with positive feedback received.

Questions to ensure internal audit is delivering value:



- ✓ Does internal audit understand the impact of emerging risk areas such as digitisation, outsourced technology provision, impact of remote working and service delivery in a pandemic?
- ✓ Does internal audit address necessary strategic and reputation risks including conflict of interest, media management, and stakeholder engagement targeted at council constituents?
- ✓ Do your internal auditors truly understand your risks, their management and challenges faced by you as a Local Government entity? Do you feel that the audit plan appropriately reflects the risks faced by you and incorporates Council's vision and future focus?
- ✓ Do your internal auditors make the most of data analytics to better understand root cause and data anomalies?
- ✓ Are you snowed under by all the Acts, Laws and Regulations you must constantly monitor and adhere to? Do you receive regular updates of findings from integrity agencies (i.e. VAGO, IBAC, Ombudsman etc)?
- ✓ Is your internal audit team graduate heavy or sufficiently experienced with Local Government?
